# Nourishing Long Valley: A Farm to School Initiative for Sustainable Community Wellness Background & Need

#### Introduction:

Long Valley School (LVS) is excited to embark on a transformative journey with the Farm to School program, a community-driven initiative aimed at addressing food scarcity and fostering sustainable agricultural practices in Doyle, CA at Long Valley Charter School. Designated as a distant rural area, Doyle has with a significant low-income population and a dearth of local grocery stores, the need for a comprehensive Farm to School plan is critical to ensure the well-being of the community.

# Current Status and Project Integration:

Doyle currently lacks Farm to School initiatives, exacerbating food scarcity issues. This turnkey project seeks to fill this void by initiating a program at the Doyle site. Looking forward, the plan is to leverage the school's 100 acres of land in subsequent years, creating a sustainable model that aligns with the comprehensive Farm to School plan.

# Project Team and Community Representation:

Long Valley has a small staff and requires additional support. Janice Gotcher, the Community Outreach Coordinator will utilize four hours per week to manage the project. To supplement the school's capacity, a third-party collaboration was identified. Along with Thrive, a non-profit educational consulting firm, LVS is set to embark on a comprehensive action plan for farm to school initiatives. This inclusive approach encompasses forming a planning team, drafting a project vision and mission, conducting surveys, and visiting other schools. The project team comprises a diverse blend of school leadership, teachers, parents, students and community members, ensuring that it not only mirrors the demographics of the community but also prioritizes the community's values, cultures, and needs in decision-making processes.

# Experience and Background:

While LVS is new to Farm to School initiatives, prior successful engagement with grant programs like Multi-tiered Systems of Support (MTSS) and the Strong Workforce Program (SWP) showcases the organizational capability. These programs have empowered the school to support students effectively, laying a solid foundation for the proposed Farm to School project.

# **SUMMARY:**

Long Valley School was awarded a planning grant in 2023 which completes 6/30/25. I did not think the grant was available for non-classroom-based schools and have learned that is not the case at this time.

The state is only offering implementation grants at this time. Both schools are eligible. The competitive grants amount for our size schools are up \$250,000, with a one-third match requirement. The grants are for a paid this amounts each year for five years.

The recommendation is to apply for up to \$150,000 for each school which would require a match in cash or in services of \$50,000 each year per school. Anticipated activities for each school include:

# Long Valley School

- Continue to employ Janice Gotcher full time to accomplish parent outreach to assist with improving attendance and building culture with families, staff, and the community; if the school receives the USDA Farm to School grant, Janice would manage this project as well.
- Support Portola with a one day per week coordinator
- Continue to work with Thrive to provide support.
- Employ student tutors for after school in Doyle and to support independent study students.

# Thompson Peak Charter School

- Work with Thrive to identify and define goals/ outcomes for the school
- Hire a community school coordinator
- Plan and implement parent/student events to support school culture.
- Provide student tutoring to improve academic achievement

#### **CHALLENGES WITH EDTEC**

We are struggling with edtec. You will notice there are additional check registers with corrections in this month's finance report. One of our admin caught an expenditure that was not part of LVS and realized it was actually for TPC. This resulted in the audit of all records and they found 27 expenditures between August and November that were coded to the wrong school as the result of an error by edtec's accounts payable representative.

We are also continuing to have issues with the payroll department; sick leave totals are incorrect and every month has some errors requiring El's time to DEEPLY review.

I've been in touch with edtec's CEO to share our concerns. He has promised process improvement. I've also been in touch with DMS to see if it was an option to return. DMS's CEO has acknowledged that the person who assigned to us that caused our exit did not have the knowledge base needed and is no longer employed.
